

2025 Annual Benefits Enrollment

Pre-65 Retirees
Enrollment Period Ends October 25, 2024

The fall season is here! That means it's also time to decide if you need to make any changes to your Emory retiree benefits. Emory's 2025 annual benefits enrollment period will run through October 25, 2024.

All Enrollment Information is Online

Visit the Pre-65 Retiree Annual Enrollment website at www.hr.emory.edu/pre65retiree to review your benefits options, download the 2025 Pre-65 Retiree Benefits Guide, and get the forms you need to make any changes to your benefits. If you are unable to access the enrollment information online, you can contact McGriff, our third-party vendor, at 678-367-3107 for assistance.

If you do not wish to make a change to your medical, dental, or vision coverage, or your life insurance beneficiaries, you DO NOT NEED to complete any enrollment forms.

Medical, Dental, and Vision Coverage

As an eligible Pre-65 Emory retiree or spouse, you can choose medical, dental, and/or vision coverage for you and your eligible dependents. You can also cancel your Emory coverage during the annual benefits enrollment period.

Medical coverage is available through the Aetna POS Plan. Due to continued rising medical costs, retiree medical plan rates are increasing for 2025 (see below). Rates for the dental and vision plans remain the same as last year.

To pay for coverage, Emory offers the convenience of automatically drafting your checking account through ACH. If you do not already have an automatic draft set up with McGriff, you will need to complete their ACH form located on the website.
